

Fund Objective

The primary objective of the portfolio is to deliver maximum capital growth over the long-term through investments in predominantly the equity market.

Fund Strategy

The portfolio's investment universe consists of equity securities listed on the Johannesburg Stock Exchange and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes, registered in the Republic of South Africa. The portfolio will be allowed to invest in listed and unlisted financial instruments (derivatives) as allowed by the Collective Investment Schemes Control Act from time to time in order to achieve its investment objective. The manager shall be permitted to invest on behalf of the portfolio in offshore investments as legislation permits.

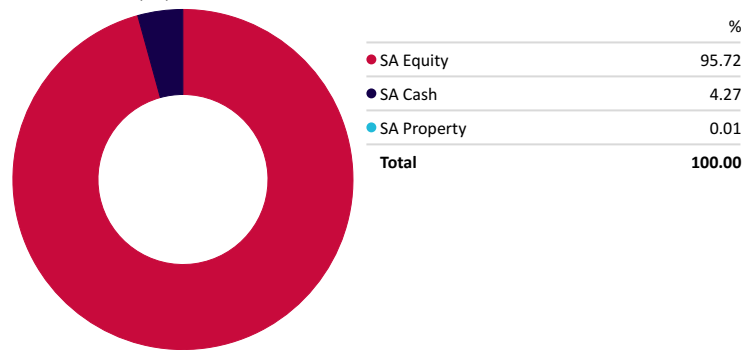

Risk Profile**Aggressive**

Glossary Terms**Annualised Returns**

Annualised return is the weighted average compound growth rate over the period measured.

Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

Capital Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or capital value fluctuates over a certain period of time. Funds with high volatility usually offer the potential for higher returns over the longer-term than low volatility funds.

Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Derivatives

Derivatives are instruments generally used as an instrument to protect against risk (capital losses), but can also be used for speculative purposes. Examples are futures, options and swaps.

Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, biannual or annual distribution pay-outs.

Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

Fund Objective

The fund objective is the portfolio's core goal.

Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

Performance Fee

Performance fees are incentive fees earned by the manager for performance in excess of the benchmark.

Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an investment.

Portfolio Manager Comment**As at 31 March 2021**

Global equity markets continued to perform well during the first quarter of 2021 with the MSCI World Index returning 5% during the quarter and 18% from pre-Covid levels reached in February 2020. Markets benefitted from both the improved momentum in vaccine rollouts as well as the US Democrat election victory early this year which paved the way for a USD 2.2 trillion fiscal stimulus package. Improved global growth expectations and a higher medium term inflation outlook has resulted in developed market bond yields rising and cyclically sensitive equities driving equity markets higher.

Global growth optimism also benefitted commodity prices with oil prices up 22% and copper 13% year to date (YTD). Particularly relevant to South Africa miners, Platinum Group Metals (PGM) prices continued to perform ahead of expectation driven by strong platinum and palladium prices and a 55% rally in the Rhodium price during the quarter.

South African equities performed well with the JSE Capped SWIX returning 3.7% in March and 12.6% YTD. SA Resources continued to outperform their industrial and financial counterparts during the quarter returning 18.7% vs 13.0% and 3.8% respectively. The local equity market rally continues to be driven by global factors, which benefit local resource producers and select rand hedges, while SA sensitive stocks continue to be plagued by specifically domestic issues, such as the poor rate of our vaccine rollout and weak business confidence.

Despite much improved performance in March, the Northstar SCI Equity Fund underperformed the local equity market, returning 10.1% for the first three months of the year versus, as mentioned above, 12.6% for the Capped SWIX. Whilst the fund benefitted from exposure to high conviction calls such as MTN, Shoprite, Sasol and Mr. Price, an underweight position to diversified miners and PGM producers detracted from performance.

Positioning and expectations

The fund is well diversified across market sectors but conviction is highest among SA industrials and select Rand hedges, which combined, make up over 50% of the fund. Whilst we acknowledge that resources have performed well ahead of our expectations, we remain underweight the sector and believe that diversified and PGM miners in particular, are discounting unsustainable commodity price assumptions into the future.

During the quarter we marginally reduced the fund's industrial exposure, taking profits from a number of positions, which have performed exceedingly well over the past year, such as Mr. Price, Naspers/Prosus and MTN. We are encouraged by the number of opportunities we see in our local buy-list and due to attractive valuations have been able to introduce a number of positions such as AVI, Mondi, Santam and Goldfields into the fund.

Based on our fundamental work, our outlook for the local equity market remains positive and we expect robust prospective returns for the year ahead.
